# Twenty-Second Sunday in Ordinary Time

In today's Gospel, the Pharisees complain to Jesus that some of his disciples are not following the laws of cleanliness. As Peter Kreeft points out in his book *The Man Who Left His Mark* **Phariseeism** is not confined to ancient Israel. "My grandfather says his generation was much more moral than ours because they avoided

"uncleanliness". They believed that "cleanliness is next to godliness."

Jesus goes on to say, "Nothing that enters one from outside can defile that person; but the things that come out from within are what defile." Matter cannot hurt spirit. You cannot punch a ghost. **The soul can be harmed only from within.** 


Jesus concludes with, "What comes out of a man is what defiles a man." Peter Kreeft paraphrases: "Man differs from monkey in that his head is dirtier than his tail."

Purity in Everyday Life

The purity of soul that Our Lord asks of his followers is far from being simply a matter of appearances. We are not expected to 'wash' our hands and plates and leave our heart unclean. Purity of soul (chastity, in the area of sensuality, and rectitude in our other feelings and inclinations) has to be really appreciated and joyfully sought after, basing our effort always on the grace of God. This interior cleanness (a necessary element of all love) is the consequence of a life-long, cheerful and unremitting struggle. The soul, if it is not to consent to attitudes and thoughts which separate it from God and from others, needs the help of a daily examination of conscience; it also needs to have a great love for frequent and worthy reception of the Sacrament of Penance, whereby God purifies and fills it with his grace and the heart is 'washed' clean. ~ Fernandez, Francis. #### ON THE LIGHTER SIDE

Monday is Labor Day, a day "to celebrate the social and economic achievements of American workers." So, what's the difference between a job and a career?

The noun *job* meaning *a piece* of work, was first recorded in the mid-16th century. By the mid-17<sup>th</sup> century, the word had also come to mean "continuous labor for pay." The term began as *jobbe*, which is a variant of *gob* or *lump* and **means** specific work for money.

Career started out as a Latin noun carrus, or "Chariot," and evolved into several meanings, including "to speed." Generally, during the Middle Ages, career was employed to describe a running course such as the sun's transit across the sky or even a racecourse. In the early 20th century, career began to mean the progression of a life's work, while job remained a particular piece of work or a paid position of employment. Career can still mean a racecourse, only today it is run by rats. ~Now You Know BIG Book of Answers.

## Faith vs. Fiction - Anti-Catholic Myths

# Myth #1 - The term "Dark Ages" was to mock the Catholic religion

- 1. The term "Dark Ages" originally had a very narrow definition. Petrarch (14th C.), and later, Caesar Baronius (17th C.), are generally acknowledged as the coiners of the term. Petrarch, in his defense, was only talking about a (supposed) dearth of good literature in Italy during his own time. Baronius was only talking about a (supposed) lack of historical sources in the 10th and 11th centuries. Both were mistaken, but neither meant the insult to become as generalized as it did.
- 2. *Historians don't use the term "Dark Ages" anymore.* It is universally acknowledged to be an inaccurate label for an era in history that saw incredible advances in art and culture.
- 3. The darkest of the Dark Ages pre-1000 A.D. was a time of immense flourishing in Western Civilization. This was the time of the birth and early growth of monasticism. Monasteries would become the preservers and centers of culture, learning, and community for centuries and centuries to come.

### YOU MAY HAVEA SEXUAL ABUSE CLAIM OR OTHER CLAIM AGAINST THE DIOCESE OF SACRAMENTO

On April 1, 2024, The Roman Catholic Bishop of Sacramento aka Diocese of Sacramento filed a chapter 11 bankruptcy petition for protection under title 11 of the United Stated Code.

If you were sexually abused by any person connected with the Diocese, you must file a claim so as to be received by October1, 2024, or otherwise you will be forever barred, estopped, and enjoined from asserting such claim against the Diocese.

Claims based on acts or omissions of the Diocese that occurred before April 1, 2024, must be filed on or before October 1, 2024, even is such claims are not now fixed, liquidated, or certain or did not mature or become fixed, liquidated, or certain before April 1, 2024.
